  - Paid position every 2 weeks with hours managed by Board President and approved by Board Treasurer
- ARC Committee members
  - Need to replace Lori at least
  - Ideally need 2 more volunteers to replace Board positions so Committee is independent of Board
  - How do we find volunteers?
  - Dan Mills offers to volunteer POST-Board Position
  - Kaelene volunteered to take Lori's place on the ARC Committee, without any Board objections
  - Kalene is going to work on finding volunteers for the ARC Committee
  - Report out next month on progress
- FY24/25 Budget Update
  - Budget Highlights
    - No Dues increase, but Net Income will be tight
    - P/T Assistant adding expenses (wages, repairs & maintenance)
    - Landscaping +\$12K for Rexius (does not include Sunday Drive common areas)
    - Supplies, Postage increased due to quarterly newsletters

- Legal Fees for deeded common areas from Sunday Drive
- Need Board Approval VOTE
- VOTE RESULT = APPROVED
- Garden Lake Park walkway/access bridge
  - Share City easement request
  - Share City Trespassing signage request
  - Share City approach plan
  - City needs to know this week. If not Budgeted, high potential it doesn't get built for 3+ years
  - Need Board Approval VOTE on proceeding with City Requests
  - VOTE RESULT = NO on the bridge easement
- Water Fountains UPDATE
  - Stewart Samuels report out shared
- Sunday Drive Phase IV (1 sold, 2 rented, all others vacant or unbuilt)
  - Common areas are still responsibility of Pliska Investments until deeded over to HOA
  - Dave to check GMAIL account for email with wrought iron fencing must match property lines

  - ARC Committee needs to address the backyard structures being built on Sunday Drive lots
  - Ask Assistant to reach out to Property Management Co so renters clean up trash on side of house

  - Review Kaelene's proposal
  - Review Board Secretary Kirk's proposal
  - Need Board Approval VOTE on proceeding with Kaelene's proposal
  - VOTE RESULT = APPROVED for up to \$2,000 to add/replace 6 trees (3 red Maple, 3 Green Maple)
  - Kaelene to purchase and deliver, Mary to coordinate with Rexius on installation/planting
- BIRDS! (Bird Houses and Osprey)

  - Need Board Approval VOTE on proceeding with Stewart's proposal
